The Chairman asked Ms. Upshur to review and highlight matters from the Office of Economic Development and Tourism's Staff Report. Ms. Upshur highlighted the following matters:

- The Office of Economic Development and Tourism is in the process of hiring for three open positions and had previously noted that Clayton Copper is transitioning to a new position as Economic Development & Tourism Coordinator.
- The Industrial Revitalization Fund application for Vector Space as discussed in the last meeting, will be submitted on August 19th.
- The Office of Economic Development and Tourism is working with a cross-departmental team on development of the venue in Riverfront Park.
- The Office of Economic Development and Tourism hosted the Secretary of Agriculture, the Commissioner of VDACS, and other stakeholders for a tour and meetings with Seven Hills Food.
- The Office of Economic Development and Tourism hosted Secretary of Commerce and Trade for regional tours of the City.
- Ms. Upshur reported that the Office of Economic Development and Tourism would host the Fall 2022 Virginia Economic Developers Association conference to be held at the Virginian Hotel.
- The Office of Economic Development and Tourism is preparing fall cohort of CO.STARTERS; and is in the process of recertifying all facilitators.
- Ms. Upshur explained the digital kiosk locations.
- As previously announced, the EDA is expected to receive a \$500,000 brownfield grant.

MINUTES OF MEETING OF THE FINANCE COMMITTEE OF THE ECONOMIC DEVELOPMENT AUTHORITY OF THE CITY OF LYNCHBURG, VIRGINIA

August 18, 2022

A meeting of the Finance Committee of the Economic Development Authority of the City of Lynchburg, Virginia, was held immediately following the Authority's meeting on Thursday, August 18, 2022, in City Council Chambers, 1st Floor, City Hall, 900 Church Street, Lynchburg, Virginia, on call of the Chairman and upon written notice to the Directors.

Also present were the following: Theodore J. Craddock of Caskie & Frost, P.C., counsel for the Authority, John M. Stone, Chairman and ex officio member of the Committee, R. Sackett Wood, Director, Marjette Upshur, Director of the Office of Economic Development and Tourism, Anna Bentson, Assistant Director of the Office of Economic Development and Tourism, Clayton Copper of the Office of Economic Development and Tourism, Eddie Horner and Mike Hoover of Caprin Investments.

Mr. Hoover addressed the Finance Committee and reviewed the Caprin Asset Management Account Review. Mr. Hoover discussed a market recap and highlights of the fixed income market. Mr. Hoover discussed the average maturity, credit quality and average yield to maturity of the portfolio managed by Caprin. The Chairman asked what constraints were on the average maturity date of the portfolio. Mr. Hoover stated that if the advisors felt the need to extend the length of the securities, Caprin would contact the Authority.

The Directors present thanked Mr. Hoover and Mr. Horner for handling the account.

The Chairman then asked Ms. Bentson to discuss a recommendation by the Office of Economic Development and Tourism that the Authority serve as fiscal agent for an allocation from the Virginia Tourism Corporation of American Rescue Plan funds. The program requires that a spending plan for the allocation be approved by Virginia Tourism Corporation by December 30, 2022. Ms. Bentson stated that the request for the Authority to be fiscal agent was an information item and that the full Authority would be requested to consider this request at a subsequent meeting of the Authority.

There being no further business to come before the meeting of the Committee, the meeting was adjourned at 10:30 a.m.
