MINUTES OF MEETING OF THE ECONOMIC DEVELOPMENT AUTHORITY OF THE CITY OF LYNCHBURG, VIRGINIA

April 20, 2023

The meeting of the Board of Directors of the Economic Development Authority of the City of Lynchburg, Virginia, was held in City Council Chambers, 1st Floor, City Hall, 900 Church Street, Lynchburg, Virginia, at 8:30 a.m. on Thursday, April 20, 2023, on call of the Chairman and upon written notice to all of the Directors. The Chairman called the meeting to order and after roll call declared a quorum present and the meeting open for business.

Ms. Upshur reported the Office of Economic Development & Tourism had recently selected seven firms from the Request for Proposals for Professional Services. One of these firms will assist the Office and the Authority with the recent GO VA Grant for Airport Commerce Park and Sites A & B in Ivy Creek Innovation Park

Ms. Bentson reported to the Authority that she has been the acting Director of Communications and Public Engagement in addition to her Assistant Director role in the Office of Economic Development and Tourism. She reported that she has been appointed the City's Director of Communications and Public Engagement, effective April 15th. The Directors thanked her for her excellent work on behalf of the Authority and the City.

Ms. Upshur reported she traveled to Atlanta Georgia with Megan Lucas, Lynchburg Regional Business Alliance, and VEDP to make a presentation to Site Selectors and the prospect for Project Grey Platinum. The sites of interest are the RiversEdge Furniture building and Sites A, B & C in Ivy Creek Innovation Park.

Ms. Upshur stated that the initial kick-off meeting with the Berkley Group for the City's comprehensive plan was held on March 24th.

Thereafter, on motion duly made by Ms. Snead, seconded by Mr. Tugman, the Board went into closed session to discuss: (i) a prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the business' interest in locating or expanding its facilities in the City, pursuant to Section 2.2-3711(A)(5) of the Virginia Code; and (ii) consideration of the acquisition of real property for a public purpose, or of the disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the Authority pursuant to Section 2.2-3711(A)(3) of the Code of Virginia.
