MINUTES OF MEETING OF THE ECONOMIC DEVELOPMENT AUTHORITY OF THE CITY OF LYNCHBURG, VIRGINIA

June 15, 2023

The meeting of the Board of Directors of the Economic Development Authority of the City of Lynchburg, Virginia, was held in the Conference Room of the Office of Economic Development & Tourism, 2nd Floor, City Hall, 900 Church Street, Lynchburg, Virginia, at 8:30 a.m. on Thursday, June 15, 2023, on call of the Chairman and upon written notice to all of the Directors. The Chairman of the meeting called the meeting to order and after the roll call declared a quorum present and the meeting open for business.

The Directors considered the minutes of the Authority's meeting held on May 18, 2023, which had previously been distributed to the Directors. Ms. Upshur reviewed with the Directors the Staff Report of the Office of Economic Development and Tourism, and highlighted the following matters in her report:

- Ms. Upshur reported that the Lynchburg City Council reviewed and approved the City of Lynchburg's full CIP Budget at its June 13, 2023 meeting;
- Ms. Upshur reported that due diligence contracts for both the Airport Commerce Park and the GO Virginia due diligence of the Ivy Creek Innovation Park had begun;
- Office of Economic Development staff had delivered Local Redevelopment Program awards to 12 businesses in the City;
- Ms. Upshur reported that the City was still in the running as a potential location for Project Grey Platinum. The City is the only municipality in Virginia being considered at this point.

Thereafter, on motion duly made by Ms. Snead, seconded by Ms. Soerensen, the Board went into closed session to discuss: (i) a prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the business' interest in locating or expanding its facilities in the City, pursuant to Section 2.2-3711(A)(5) of the Virginia Code; and (ii) consideration of the acquisition of real property for a public purpose, or of the disposition of publicly held real property, where discussion in an open meeting would adversely

affect the bargaining position or negotiating strategy of the Authority pursuant to Section 2.2-3711(A)(3) of the Code of Virginia. The motion was adopted, with the following voting:
