MINUTES OF MEETING OF THE ECONOMIC DEVELOPMENT AUTHORITY OF THE CITY OF LYNCHBURG, VIRGINIA

October 19, 2023

The meeting of the Board of Directors of the Economic Development Authority of the City of Lynchburg, Virginia, was held in the Conference Room of the Office of Economic Development & Tourism, 2nd Floor, City Hall, 900 Church Street, Lynchburg, Virginia, at 8:30 a.m. on Thursday, October 19, 2023, on call of the Chairman and upon written notice to all of the Directors. The Chairman of the meeting called the meeting to order and after the roll call declared a quorum present and the meeting open for business.

The Directors considered the minutes of the Authority's meeting held on September 21, 2023, which had previously been distributed to the Directors. Thereafter, on motion duly made by Mr. Wood, seconded by Ms. Soerensen, the Directors present unanimously approved the minutes of the September 21, 2023 meeting of the Authority as submitted, with the following voting:

The Directors discussed a review of the By-Laws of the Authority. Ms. Upshur reported that By-Laws were last revised in July 2020 to provide for virtual meetings of the Authority during the COVID-19 pandemic. The Directors determined to review the By-Laws and make suggestions concerning matters of notice and update a consideration of the duties of the Officers. The Chairman asked Mr. Craddock to review the By-Laws and to make suggestions of amendments.

The Chairman then asked Ms. Upshur and Mr. Copper to review the Staff Report dated October 19, 2023. Ms. Upshur reported on the following matters:

- The Office of Economic Development and Tourism completed the fiscal year annual report for distribution.
- The Office of Economic Development and Tourism held the annual "Taking Care of Business" event, which was well attended at The Glass House on October 12th.
- Due diligence work continues on the two grant funded projects for the Airport Commerce Park and Ivy Creek Sites A & B by Dewberry Engineering.
- Mr. Copper made a report on cutting any marketable timber on Sites A & B.

Thereafter, on motion made by Ms. Soerensen, seconded by Ms. Snead, the Board went into closed session to discuss: (i) consideration of the acquisition of real property for a public purpose, or of the disposition of publicly held real property, where discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the Authority pursuant to Section 2.2-3711(A)(3) of the Code of Virginia, and (ii) a prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the business's interest in locating or expanding its facilities in the City, pursuant to Section 2.2-3711(A)(5) of the Virginia Code.
